**POSITION SUMMARY:**

Responsible for planning, developing, coordinating, and implementing education on a variety of topics which include nutrition, physical activity, substance abuse, and mental health for the Pueblo of Jemez. Coordinates activities with colleagues, local schools, JHHS medical staff, tribal programs, and local/state/federal partners to advance the health of target populations and the overall community; implements community assessments and inputs data for school health surveillance under the direction of the School Health Manager. Involved with the planning and implements of various program activities that are culturally relevant and developmentally appropriate. Assigned to shadow various health/education/community professionals based on professional interest and career path.

- Promotes the preservation of Jemez culture and language in program planning and implementation.
- Maintains good working relationships with students, families, community programs, volunteers, and external agencies.
- Mandatory reporter of all suspected incidents of child abuse and neglect.
- Attend all staff meetings associated with school health initiative and other related trainings.

## **REQUIRED KNOWLEDGE AND SKILLS:**

- Ability to facilitate efforts to inform the community of services for school-aged population.
- Ability to coordinate and facilitate community outreach activities for students and their families.
- Knowledge and understanding of school health initiatives, including health promotion and disease prevention programs for children and adolescents.
- Knowledge and understanding of early childhood initiatives.

- Knowledge of implementing evidence-based health education, health promotion programs.
- Ability to communicate effectively, verbally, and in writing.
- Good organizational skills.
- Ability to gather data and process measures.
